Instructions



- 1. Collect urine specimen from donor (20-30mls max)
- Remove cap from test device **
- 3. Insert test strip into urine or (urine sample should **not** touch the plastic card) only immerse to the indicated line (arrow)

Once test window turns pink recap and lie on a flat surface

**Remove test cap

- 1. Read results in 5 minutes
- 2. Interpret results,

2 lines = negative


1 line = positive

Reading Results

- Negative results can be read as soon as they appear
- Read positive (non negative) results at 5 minutes
- All positive results are presumptive and should be confirmed by GC/MS

(Gas Chromatograph/Mass Spectrometry)





NEGATIVE POSITIVE

Negative = Pass— No drugs detected at cutoff levels

Positive = Fail—drugs detected at or above cut-off levels -

INVALID

C = Control T = Test

Line Intensity (colour) in **NOT** important. A feint 2nd line if visible must be read as a NEGATIVE result (pass)
